Provost Jenny McNulty

*McNulty introduced herself to senate stating her role on campus as Provost and Vice-Chancellor of Academic Affairs. Asked for questions or concerns from senate.

*Senator Davies asked about Covid response. McNulty explained the difficult tasks that have been handed to universities during the pandemic.

*Senator Wiggins asked about spring schedule finalizations and changes. Provost McNulty explained the process of creating the spring schedule and the request of BOR to use scheduled spring break as instructional time.

*Senator Smith reported results of a survey of students taken by RA's noting that many students in residence halls have expressed concern and have indicated they will leave or transfer. Provost McNulty noted that the SEA is putting out a survey to students in the upcoming weeks.

*McNulty asked for input on a possible Block 9 to help students catch up or make-up lost class time due to Covid schedule changes or quarantine/isolation. Senators expressed concerns over affordability, class availability, etc.

*Senator Christenson noted that many horse/rodeo students have concerns over fees that will be assessed to stay in the dorms after Thanksgiving as they have horses to care for. Noted that students are concerned about cost of staying in Dillon to care for horses. McNulty noted that there would be no extra fees assessed until December 16, which is customary.

*Provost McNulty asked about ideas for a possible Halloween event. Concerns from senate about late notice as most students already have plans. Students asked if this type of event sends the wrong message about keeping gatherings to less than 10.

New Student Concerns/Comments:

Senator Wiggins noted that several students have noted new fees on their bills. Dean Hazelbaker said students can ask about the fees and administration can look into the fees on a case-by-case basis, as there are not supposed to be any new fees, as they have not been passed through Board of Regents.

Senator Randolph noted that students have complained about the dorms being cold. Noted that she advised students to talk to their RA. VP Kunze also noted he would bring the issue to Mike Piazzola.

Reported that the X-1 Grant process is open, although there have not been any applications as of yet.
