Montana Western COVID-19 Guidelines: 2021-22

The University of Montana Western is committed to providing high-quality instruction and a safe environment for students, staff, faculty, and our community during the 2021-22 academic year. We understand that local, state, and national health situations will continue to evolve and guidance will be adjusted accordingly.

Below are key points regarding the UMW 2021-22 Academic Year:

Course Delivery

- UMW is open for Fall 2021. Face-to-face courses will resume and we do not anticipate changes to the course schedule or mode of instruction. However, we will continue to monitor the COVID-19 situation and will follow guidance from Beaverhead County Public Health as needed.

COVID-19 Vaccinations

- Faculty, staff, and students are not required to be vaccinated against COVID-19. However, the CDC has said that the COVID-19 vaccine is an important tool to stop the pandemic. Vaccination clinics will be available on campus for faculty, staff, and students during the Fall semester. UMW strongly encourages all community members to work with their healthcare provider to determine an appropriate vaccination course.

Masks

- Effective as of September 9, 2021, at the recommendation of the Beaverhead County Public Health Department, we require individuals on our campus – vaccinated or not – to wear masks indoors in all classrooms, labs, and other indoor instructional spaces or settings where social distancing is not possible. Masks continue to be strongly recommended when in any indoor publicly occupied spaces.
- Students who need a mask can pick one up for free at the Bulldog Life Office in the basement of the SUB, or at offices in the Short Administration Building, including Business Services and the Registrar.
- This guidance will be revisited no later than October 15, 2021, at the end of Block Two.
- Montana Western expects all faculty, students, and staff to be considerate and respectful to those wearing a mask.
- Additionally, as a friendly reminder, please do not come to campus if you are feeling sick.

Social Distancing

- At this time, social distancing is not mandated on campus. However, some people may feel more comfortable if they are able to maintain a distance from others. Please be mindful of others' personal space and respect others' decisions regarding distancing.

Hygiene and Health Monitoring

- At all times, good hygiene is important for our individual and community health. Students, faculty, and staff are strongly encouraged to wash their hands regularly and use hand sanitizer. Likewise, students, faculty, and staff are expected to cover coughs and sneezes. Any individual experiencing cold or flu-like symptoms should avoid close interactions with others and call their healthcare provider for guidance. Free COVID-19 testing is available through Southwest Montana Community Health Center and Barrett Hospital & HealthCare.

Isolation

- Beaverhead County Public Health will conduct contact tracing and determine the need for quarantine or isolation on an individual basis. Individuals who are vaccinated will NOT need to quarantine based solely on contact with infected individuals.

Class Attendance and Absences

- Individual faculty members set the attendance policies for their classes. For information about the attendance policy in a class, students should consult the course syllabus. In all cases, if a student will miss class for any reason, they should notify the instructor before the start of class.
